**SUBJECT: RESULT OF THE EXAMINATION FOR THE POST OF

The Written Test, Simultaneous Interpretation Test and Personal Interview of the candidates for filling up vacancies for the post of Parliamentary Interpreter Gd.-II in English/Hindi stream were held from 01.04.2016 to 03.04.2016. Each test was elimination round for the subsequent test.

2. On the basis of the aforesaid tests, the following candidates have been declared qualified for appointment to the post of Parliamentary Interpreter Gd.-II (English/Hindi) in Lok Sabha Secretariat: -

**The candidate belongs to 'OBC' category. He has not availed any relaxation available to the candidates belonging to 'OBC' category in the prescribed eligibility conditions for the said post or for qualifying this examination. Hence, he has been declared qualified against 'UR' vacancy.*

3. In Simultaneous Interpretation Tests, the candidates were required to secure minimum 50% marks in each component/parameter. The minimum cut-off percentage of marks in Written Test (in each paper/component) and Personal Interview was 50%, 45% and 40% for vacancies in GEN, OBC and SC/ST categories, respectively.
