2. The cut-off percentage of marks in the above Preliminary Examination is as follows:
- UR vacancies: 50% in each component and aggregate
  - OBC vacancies: 45% in each component and aggregate
  - SC vacancies: 40% in each component and 49% in aggregate for English stream  
40% in each component and 40% in aggregate for Hindi stream
  - ST vacancies: 40% in each component and aggregate
3. The candidates should bring copies of the following certificates **duly attested by a First Class Magistrate or Gazetted Officer** at the time of Main Examination:
- Matriculation or equivalent examination certificate as proof of date of birth.
  - Graduation or examination for higher educational qualification last passed [before the last date for submission of applications for the post of Stenographer in response to Advertisement No. 5/2014]
  - Category/Caste Certificate (SC, ST and OBC certificates)
