**Tender Notice Dated 23/12/2020 for Registration of authorized supplier for purchase of Chicken and Eggs.**

Sealed quotations are invited from wholesale and retail firms for registration as the authorized supplier for supply of Chicken and Eggs on regular basis to Lok Sabha Secretariat.

2. Firms authorized to supply the aforesaid items may submit sealed quotations clearly mentioning their Official Address, Telephone No./Mobile No./ E-mail ID along with necessary documents to Room No.47, Central Command Station, Parliament House, New Delhi-110001 within 15 days from the date of publishing of this notice. The sealed quotations should reach this office latest by 1300hrs on 06/01/2021 and will be opened on the same day at 1600hrs at the above mentioned address in the presence of the authorized representative(s) of the firm(s) who may like to participate in the process. Full particulars of the nominated representative(s) may be forwarded by the participating firms on the official E-mail ID of Lok Sabha Secretariat i.e., CCS-LSS@SANSAD.NIC.IN latest by 1400hrs on the day of opening of the sealed quotations.

3. Applications with incomplete details will be summarily rejected. The registration shall be valid for a period of 03 (Three) years from the date of registration. The Secretariat reserves the right to accept or reject the offer of any party without assigning any reason.

4. The terms & conditions for registration are enclosed as Annexure-I.

**Terms & Conditions for registration of authorized supplier for purchase of Chicken and Eggs:**

- (a) Registration of supplier is for a period of 03 (Three) years from the date of registration.
- (b) The registration may be terminated by Lok Sabha Secretariat at any time during its currency by serving one month's notice.
- (c) Since it is mandatory for the registered supplier to be boarded on the Government e-Market Place (GeM) as and when the item or service gets listed on GeM, the registration in such a case may also be terminated by the Secretariat.
- (d) Quotations submitted by the firm should indicate the cost of supply for fresh rations items i.e., Chicken and Eggs including all taxes. The rates shall be valid for a period of 01 (One) year from the date of registration. For the second and third year the items may be continued to be supplied at the quoted price or may be considered for enhancement in line with the inflation rate on request of the supplier with the approval of the competent authority.
- (e) The firm offering lowest price among the eligible suppliers shall be considered as L1 and recommended for registration as the authorized supplier for supply of fresh ration. The registration date shall commence from the next date of award of the contract.
- (f) Fresh ration demanded by LSS as per requirement shall be supplied by the authorized supplier to 23, Mahadev Road, Telephone No.23327090 on payment basis at the rates as offered in the quotation along with bills.
- (g) If the required fresh ration is not available with the registered supplier, then the supplier is required to arrange the same from any other source at the same rate as it is offered in the quotation without compromising on the quality.
- (h) At the end of the term, the authorized supplier is required to apply afresh to Lok Sabha Secretariat for registration with other competing firms.
- (i) Approximate quantity of chicken and eggs likely to be purchased by Lok Sabha Secretariat annually are as under:

Sl. No.	Items to be supplied	Approx. annual quantity
(i)	<u>Chicken:</u> Dressed Broiler Chicken without head, feet, gizzard and skin weighing 800-850 grams. The broiler should be properly and securely packed. Neck should not be longer than 2" from carcass.	1100 dressed broilers (each weighing not less than 800grams)
(ii)	Eggs	2500 Nos.
