However, hard Copies of Notices of Unstarred Questions will continue to be received in the Parliamentary Notice Office and other designated places from **Thursday 3rd September, 2020**. Notices for a particular date of sitting received upto 1000 hours of the date of holding Ballot for that sitting will be included in the said Ballot. Where such notices are received before fifteen days from the day for which they are intended to be included in the List of Questions, they will be deemed to have been received at 1000 hours on the 15th day before such day and their *inter se* priority will be determined by ballots.

The Ballots will be held in the Question Branch, Room No. 324, Parliament House Annexe after 1400 hours.

Members are further informed that notices of Questions for the sittings to be held on **14.09.2020, 15.09.2020 and 16.09.2020** received upto 1000 hours on 04.09.2020 will be balloted on 04.09.2020; notices of Questions for the sittings to be held on **17.09.2020, 18.09.2020 and 19.09.2020** received upto 1000 hours on 05.09.2020 will be balloted on 05.09.2020; and notices of Questions for the sittings to be held on **20.09.2020, 21.09.2020 and 22.09.2020** received upto 1000 hours on 06.09.2020 will be balloted on 06.09.2020.
