Profiles of Resource Persons

1 <u>Dr. Ravindra Singh</u> is Course Coordinator for the Certificate Courses. He joined the Institute in 2004 and is currently working as Research Officer.

He is responsible to plan and execute research projects, research activities, academic courses, training and capacity building programs, etc. and is editor of the two research journals published by the Institute - Journal of Constitutional and Parliamentary Studies (in English) and Loktantra Samiksha (in Hindi).

He also served as Associate Professor in Department of Political Science at Central University of Haryana (CUH), Mahendergardh on deputation for three years from December 2009 to November 2012. While at the university, he supervised several M.Phil. and Ph.D. scholars.

He has been usually contributing to the two journals published by the Institute. He has one book and more than 20 research articles to his credit.

2 <u>Dr Babita Singh Parasain</u> is currently serving as Joint Director in Lok Sabha Secretariat. She is doctorate in Constitutional and Parliamentary Law and also holds a Masters degree in History. She was also deputed on diplomatic position in the Ministry of External Affairs.

She delivers lectures to the participants of training/ orientation programmes in the Parliamentary Research and Training Institute for Democracies (PRIDE) earlier known as BPST. She has worked on curriculum and module development for administrative cadres.

She is sub-editor of books on Law and Legislation, 'Know your Assembly' and 'Apni Vidhan Sabha Ko Jaane', pertaining to Delhi Legislative Assembly, Delhi and has published articles in journals.



3 <u>Dr Raghab. P. Dash</u> is currently holding the position of Director (Research) in Rajya Sabha Secretariat. He has more than 25 years of service in the secretariat including eight years of service in the Office of Vice-President of India and Chairman, Rajya Sabha. Dr. Dash has recently joined back at the secretariat after serving the Union Ministry of Micro, Small and Medium Enterprises for about 3 years.

Dr. Dash did Ph.D. from the Centre for Law and Governance, Jawaharlal Nehru, New Delhi on the theme 'Law Making in Democracy: Contested Domain of Legislative-Executive Relations in India'. He has been regularly delivering lectures in various institutions including at ICPS on themes related to parliamentary studies.

Her areas of interest include Constitutional Law, International Law, Interpretation of Statutes, Environmental Law, Human Rights, and Law of Torts.

5 <u>Dr. Deepak Gosai</u> recently superannuated as Director from Lok Sabha Secretariat after serving for about three decades. Prior to joining Lok Sabha Secretariat, he served as Lecturer (Political Science) in University of Delhi from 1986 to 1993.
