Guidelines for Contributions

Articles and research papers, addressed to the Editor of the Journal, for publication in the journal are invited from persons belonging to different walks of life: legislators, jurists, political scientists, academicians, lawyers, etc. Contributions simultaneously sent for publication elsewhere, will not be entertained.

The contributions may be on any theme relating to the domain of the journal, viz. constitutional and parliamentary studies. References should be as per the Chicago Style and should be in the form of footnotes.

The contributions, preferably in the range of 5000-6000 words, may be sent to the Editor through e-mail at 'journals-icps@sansad.nic.in'. The contributors should indicate their official designation, if any, and contact details in the forwarding mail.

All contributions should be sent in MS-Word format. Contributions in Hindi for 'Loktantra Samiksha' should be transcribed in 14 points in Chandini Font. However,

numerals and words in English, if any, should be transcribed in 10.5 points in 'Palatino Linotype' Font.

The contributors are required to furnish a declaration that provisions of The Copyright Act as amended from time-to-time have been complied with and that the contributors shall be solely responsible for any issues arising out of copyright violations.

Selection of Contributions

The journals are peer reviewed and refereed journals; contributions received for consideration for publication are reviewed by domain experts nominated on the Board of Reviewers. Board of Reviewers for the journal comprises of domain experts, professionals, and academicians of repute.

The Editorial Board takes a final decision on the contributions in the light of the recommendations of reviewers.
