Lok Sabha Secretariat desires to procure one Computer System/Workstation for the use of Lok Sabha Secretariat. The particulars of system are as under:-

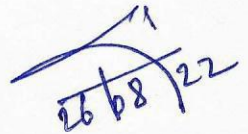

2. The item shall conform to the specification as given at paragraph at para 1 above. Interested vendors/parties, may therefore submit sealed quotation in the Tender Box placed at Reception Office(Beside/below Baggage Scanner), Parliamentary Library Building (Opposite Gurudwara Rakabganj), Pandit Pang Marg, New Delhi-110001 **on or before Tuesday, 06 September 2022 upto 1700 hrs.** No extension of deadline shall be granted under any circumstances nor any correspondence done in this regard. The envelope must be sealed and superscribed as **“Quotation for procurement of Computer System/Workstation”** and addressed to Executive Officer, Computer (HW&SW) Management Branch - Hardware Unit, Room No. FB-149, Parliament Library Building, Lok Sabha Secretariat. New Delhi-110001.

3. The warranty period of three years of system shall commence from after the date they are supplied and their installation and testing is done successful in the Secretariat. The part number and warranty of the said items may be clearly specified.
4. A Bill giving details of GST etc. alongwith serial number of aforesaid products may be furnished to this Secretariat for settlement. Processing of bills for payment shall be done after installation of items.
5. The item shall be brand new, unused, and shall have original packing of OEM. Part delivery of items shall not be accepted by this Secretariat.
6. There shall not be any variation in the specification of above items, as mentioned in the Tender Document/Request letter/Quotation.
7. The price quoted must be valid for at least 15 days.
8. No terms and conditions for supply of items by the vendor/firm will be accepted.
9. In case of manufacturing defect, the items shall be replaced within one working day of the complaint, lodged with the vendor.
10. For breach of terms and conditions mentioned in Purchase Order/Quotation, the bidder/firm may be blacklisted for doing business with Lok Sabha Secretariat.
11. In case of delayed delivery up to 15 days without valid reason, a penalty at the rate of 0.5% of the total value of the order of the items for each of week delay from the seller will be imposed.
12. Most importantly, the requisite system needs to be supplied within 07 days of placing order and receipt of the same by vendor on the email provided by him/her in the Quotation Bid.
