**Re-tender for procurement of 03 (Three) Labrador Pups.**

This has reference to 'Tender Notice dated 31/03/2021' published on the Lok Sabha website and "Tender ID No.2021\_LSS\_599014\_1 dated 31/03/2021" published on the Central Public Procurement Portal, inviting sealed quotations in two bid system for supply of 03 (Three) Labrador Pups (Sex: Male) aged between 12-20 weeks to Lok Sabha Secretariat, Parliament House, New Delhi-110001.

2. In view of the cancellation of the aforesaid tender due to insufficient qualified bids, it has been decided to re-tender for procurement of 03 (Three) Labrador Pups (Sex: Male) from reputed firms by Lok Sabha Secretariat, Parliament House, New Delhi-110001.

3. Firms willing to participate in the tender are required to submit their bids in 02 (Two) Bid System. ***The Bidder(s) should seal their Technical bid and Financial bid in 02 (Two) separate covers superscribed as "Technical bid" and "Financial bid" respectively and these covers should be placed inside a larger cover sealed and superscribed as "Tender for supply of 3 (Three) Labrador Pups".***

4. *In the Technical Bid, the bidders are required to submit the following documents:*

- (i) Acceptance of terms & conditions of the tender.
- (ii) Copy of GST number of the firm.
- (iii) Copy of registration with Kennel Club of India.
- (iv) Copy of supply order for pups from any Govt. Dept./ Public Sector Enterprise.

5. Sealed bids complete in all respects may be sent by speed post to "The Joint Director (Security), Room No.47, Central Command Station, Parliament Security Service, Lok Sabha Secretariat, Parliament House, New Delhi-110001". The bids should reach this office within 21 days from the date of publication of this notice i.e., latest by 1330hrs on 04/08/2021. In the first instance, only Technical bids will be opened on 04/08/2021 at 1600hrs at the above mentioned address. The date of opening of sealed financial bids of the technically qualified firms will be communicated to the eligible firms later.

6. Firms willing to participate in the process of opening of bids may forward full particulars of their nominated representative(s) on the official E-mail ID of Lok Sabha Secretariat i.e., “CCS-LSS@SANSAD.NIC.IN” latest by 1400hrs on the day of opening of the sealed technical bids.

7. Conditional bids and incomplete bids will summarily be disqualified.

8. Qualitative Requirements and Terms & Conditions of the tender for supply of pups are enclosed herewith as Annexure-I.

## Annexure-I

### 1. Qualitative Requirements (QRs) and Terms & Conditions:

- (i) Pups of Labrador breed, Sex: Male, to be supplied should be of 12-20(Twelve-Twenty) weeks of age.
- (ii) Pups supplied must be from the imported breeding stock or from the imported lineage. The breeder/supplier must provide proof of owning the imported Sire & Dam.
- (iii) Pups must be free from all genetic diseases including hip dysplasia and other diseases of congenital in nature. Pups should be guaranteed against any genetic diseases.
- (iv) Pups must be vaccinated and protected against disease like *Parvovirus*, *Leptospirosis*, *Canine Corona virus*, *Hepatitis*, *Rabies* etc. as per global standards. Certificate to this effect with details of vaccination in respect of each puppy to be provided.
- (v) All pups supplied should be guaranteed for 06 (Six) months post delivery. If any pup gets infected by any of the above mentioned disease as well as any physical disability in musculoskeletal system, olfactory organs, ocular system and vision which is congenital, such pups shall be replaced free of cost.
- (vi) Pups supplied should have sound and well-developed body. It should have well developed bone, proportionate body with strong back, shining coat, deep chest and muscular feet with well-cushioned paws.
- (vii) Pups must be free from faults such as bend in feet, poor shoulder placement, lack of coordination in limbs or poor body configuration.
- (viii) All pups supplied by the firm must be registered with Kennel Club of India (KCI) and Certificate to his effect should be provided while delivering the pups.

### 2. Additional Terms and Conditions:

- (i) In the financial bid the firm should give the break-up of cost of pups, taxes and transportation cost for delivering the pups from supplier's location to Parliament House.
- (ii) Participating firms should have adequate number of pups meeting the aforementioned QRs for inspection and selection by Lok Sabha Secretariat.
- (iii) No advance payment shall be made to firms towards supply and delivery of pups.
- (iv) All payments shall be settled, post satisfactory delivery of pups and submission of bills with necessary documents.
